3/02/07	<p>S: The client arrived to this treatment session five minutes late; however, he appeared eager to begin therapy. Caregiver reports that overall improvement re: communication has been noted at home and school.</p>	
	<p>O: The following objectives were addressed:</p> <p>Objective 1a. The client will correctly respond to complex “wh” questions about specific topics using minimal cues with 80% accuracy, in 8 of every 10 trials presented.</p> <p>The clinician presented the client with %wh+themes (who, what, when, where) by presenting occupational pictorial flash cards and asking %wh+ questions about them. The client achieved 80% accuracy independently and 100% accuracy using minimal to moderate verbal contextual cues.</p> <p>Objective 2a. The client will use appropriate eye contact with moderate cueing accurately 10 times in a 50 minute session.</p> <p>This objective was continually targeted throughout the entire session. (E.g. in answering a question or asking for a token the client was directed to make eye contact.) With maximum verbal cueing the client was able to achieve eye contact 10 times within a 50 minute session. However, more maximum (cueing more than 75% of the time) than moderate cueing was needed. The clinician also reviewed a social story regarding eye contact and modeled desired behavior.</p> <p>Objective 2b. The client will use pragmatically correct polite responses for various situations presented by the clinician with minimal cueing at 80% accuracy, in 8 of every 10 trials presented.</p> <p>This objective was targeted using two different methods. The clinician used social skills stories as well as giving and granting requests. This was also a review for the client. The social story targeted/addressed %interrupting+. The client achieved 80% accuracy independently on the social story scripts and 100% accuracy with minimal cueing. On making and granting polite requests, the client achieved 90% accuracy independently and 100% accuracy with minimal cues.</p> <p>Objective 2c. The client will give specific verbal responses or request a change of behavior during times of frustration with 80% accuracy in 8 of every 10 trials presented.</p> <p>The client put a 24 piece puzzle together, while the assistant attempted to take the puzzle apart or flip pieces over. The client inappropriately yelled during this task, but was redirected and was able to communicate using appropriate language with 70% accuracy independently and 90% accuracy using moderate cueing on the stated goal.</p>

	<p>Objective 3a. The client will complete outside activities and homework with 75% accuracy.</p> <p>The caregiver was asked to provide wh questions to the client about his favorite things (e.g. food, animal, color). The caregiver stated that the client had some difficulty with this but did provide a favorite food, color, and number. He was given a list of ten items to ask about and the client answered five. Thus, the client completed 50% of his outside activities.</p>	
	<p>A: The client did well with the wh activity; this may be due to the aid of the pictorial cards. The picture cues allow the client the freedom to view the card and search for the correct response. The client continues to benefit from frequent and moderate cueing for making and maintaining eye contact.</p>	
	<p>P: The clinician will continue to target short term goals. She will also try to find new ways to evoke frustration so the goal can be targeted with depth.</p>
