2017–2018 Verification Worksheet

Your 2017-2018 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information, the Financial Aid Administrator (FAA) at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the FAA at your school. Your school may ask for additional information. If you have questions about verification, contact your FAA as soon as possible so that your financial aid will not be delayed. **WARNING**: If you purposely give false or misleading information on this worksheet, you may be fined, sentenced to jail, or both. The law states that AAMU has the right to ask you for information before you are awarded any financial aid. See the instructions in the FAFSA. AAMU must review the requested information (C.F.R. Title 34, Part 668, the student financial aid rules).

- As determined by a court in your state of legal residence, does someone other than your parent or stepparent have legal guardianship of you?
- At any time on or after July 1, 2016, did your high school or school district homeless liaison determine that you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless?
- At any time on or after July 1, 2016, did the director of an emergency shelter or transitional housing program funded by the U.S. Dept of Housing and Urban Development determine that you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless?
- At any time on or after July 1, 2016, did the director of a runaway or homeless youth basic center or transitional living program determine that you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless?
